The first phase of our three-year expansion project was complete with the unveiling of our newly expanded Rehabilitation and Outpatient Therapy Center. Along with this success, CVH opened a Specialty Clinic with Urology and Physical Medicine & Rehabilitation, as well as added a new primary care location at Ironwood. In August, the first robotic-assisted surgery was performed at CVH using the da Vinci system. This machine is part of an ongoing effort to increase the surgical treatment options for our patients. We are proud of our progress, but our attitude is - let's keep climbing.
